The book covers the primary topics that arise in the typical law school criminal procedure course, including when the warrant requirement applies, the process for obtaining a valid warrant, the operation of the exclusionary rule, the range of exceptions to the warrant requirement, and arrests and other seizures of individuals and resultant searches of the person.

The authors have experience as prosecutors and defense counsel, and have written extensively in the fields of criminal law, criminal procedure, and evidence.
